Old Business

There was no old business or tabled items to discuss at this meeting.

1. All terrain vehicle activity:

President Mark DiNino (MD) presented to the neighbors that ATV traffic on the street is not allowed and illegal per discussion with the Rockland Police department. If caught the police will confiscate the vehicles and fine the offenders. He urged homeowners to report activity to the police department to keep all safe.

MD also noted that if common areas are disturbed due to ATV traffic the offenders will be caught and responsible to pay for all damage to common property.

2. Vote for President:

Neighbors who were at the meeting and identified as candidates for president through write in on the ballots respectively declined to run for president. Ballots were counted and hand vote taken. Mark DiNino received 60 ballot votes and full majority of hand votes during the meeting and has been elected president for 3 years.

3. Park Vote:

Votes were taken and ballots counted and the result was to Replace the park with Option #1 presented by the park committee. This vote will result in a one time home owner assessment of \$275 per household. The collection of this assessment will be handled in the same manner as dues collection. Homeowners will be billed by e-cratchet and homeowners who do not pay will be turned over to the attorney for collection.
